

PRESIDENT'S MESSAGE

I want to wish everyone a Happy and Healthy New Year. Hopefully 2019 will be better than the last. We are slowly making headway on cleaning up our grievance backlog. NBA Dave Napadano and Eastern Area Labor representative Mike Kulikowski came to Reading and we had a meeting to discuss the backlog; and, put a plan in place to have the issues heard. Article 15 (Dispute Resolution Process) training was given to stewards and supervisors by Mike and Dave. They will be returning in the near future to help get our labor/management meetings back on track. One thing I have learned over the years is that you cannot make the grievance procedure personal. It's about business. We have agreed upon rules, and if they are broken, disputes arise. Then the stewards file grievances. When employees do things that violate postal rules, management hands out discipline. That process gives us a chance for us to educate all parties as to what the rules are and why they are put in place.

I am happy to report that a great number of the issues have been resolved in the union's favor. Carriers are allowed to have drinks; and, they do not need permission to use the restrooms. Cell phones must be readily available in case an emergency occurs. It's 2019, I cannot fathom why we would need to have the Dispute Resolution Team settle these issues but that is just an example of where local postal management has headed. Numbers and tainted projections rule the roost. Common sense has been replaced by bullying and division. Management blames the union. The union blames management. Communication and trust are non-existent. When this happens everyone loses. Even the little tasks seem difficult to get accomplished. Production suffers, Sick Leave increases and we all become adversaries to what our mission is for the USPS. We all look for reasons not to work together and communicate. Funny we are in the communication business and we fail to talk to each other to work out our differences. I have found these times the most difficult. Hopefully we can start to move forward from here.

I want to thank everyone who wrote statements and has supported others. Management's improper rules placed hardship on many of you. It took a while to achieve positive decisions from the DRT. We even had retired carriers writing statements to refute management's misguided behavior. It proves that if we stay united we will be able to stop any mistreatment to any of our brothers and sisters. I am proud of you.

I also want to thank the shop stewards for their dedication though these troubling times. They volunteer to represent all of us. Stewards put themselves in management's crosshairs with little compensation other than the satisfaction of helping others. They spend time away from their families to learn the contract so that they are educated to represent people that may not be able to fight for themselves. All of them have had to put in hours off the clock; and, they have dealt with the stress of this backlog for too long.

I am in awe of their work; and, I am so thankful for our stewards, our board members, and all of our members that attend our monthly meetings. I wish more members would get involved, come to our meetings, read our contract, and educate themselves. All of our national officers were letter carriers just like yourselves. My experience has led me to know that our National officers have our best interests in mind. Representing letter carriers best interests are always in the forefront of their decisions and leadership.







On January 3rd, 2019, in Washington D.C., the 116th Congress was sworn in. 64 of the new members are Democrats, 60 in the House, 4 in the Senate. 36 of the new members were Republican, 30 in the House, 6 in the Senate. 40 of the new members are women, 36 in the House, 4 in the Senate. 60 of the new members are men, 55 in the House and 5 in the Senate. At least 25 of the new members elected to the House this cycle are Hispanic, Native American and people of color. All of the newly elected senators are white.

Locally, we have two new representatives in District 6 and 9. District 6, is newly elected Chrissy Houlahan and District 9 is newly elected Daniel Meuser. Unsure who represents you and in what district you live in, find out at GovTrack.us. You can also go under Government Affairs under the NALC website or their own website and read more about Houlahan and Meuser and their views.

The House Resolutions to pay attention to that affect our jobs are:

H. Res. 54 - 6 day delivery

H. Res. 28 - door to door delivery for residential and business customers

H. Res. 33 - keeping the Post Office independent and NO Privatization

Consider contacting the representative in your district and ask them to cosponsor the above House Resolutions. Let your voice be heard and tell them your concerns and how it will affect you personally. Educate yourself, friends, family and coworkers on what's going on in Congress. We need to continue to fight together and support each other and make a difference. We are Branch 258 and we are UNION STRONG!!

Alone we can do so little. Together we can do so much.




Your Role In Your Union

So, if you want to "own" your union and to share is the members' responsibility of running it, what can you do?


-Educate Yourself -Be a set of "Eyes and Ears" -Show Solidarity

Safety Happenings

We head into the new year and I wanted to talk about something we normally do not think about during the winter months, the use of sun screen. I know you are thinking what is he talking about , but I was recently told anyone who works outdoors should be using sunscreen all year round, not just in the warm weather. Winter actually *increases* your need for sunscreen because the rays reflect off of the snow, it might surprise you to know that UV rays dont discriminate against cloudy, chilly, or rainy days as well.

The latest stats show one in five Americans are expected to develop skin cancer in their lifetime, a distrubing fact and considering how many hours we work outside its very important to make sure we take the proper steps to ensure to protect ourselves, even when the sun doesn't actually feel like it's beating down on you. You deserve all the self-care in the world, and luckily, sunscreen is one of the cheapest skincare products out there.

According to the American Academy of Dermatology(AAD), sunscreen is imperative every single day if you're spending time outside. The AAD says that most people only apply 25 to 50 percent of the recommended amount of sunscreen, and recommends applying sunscreen 15 minutes before going outdoors and reapplying approximately every two hours. It is also recommended using a sunscreen with an SPF of at least 30, which blocks 97 percent of the sun's UVB rays. Sunscreen comes in many forms, lotions, sprays, and roll ons find one that you like and use it everyday.

Skin Cancer and Early Detection

Its never too late to start safe sun practices, in addition to wearing sunscreen wear sun glasses, a hat and sun-protective clothing especially during the sun intense hours between 10 AM-4 PM.


Spotting skin abnormalities early is crucial in fighting skin cancer, do a self check on your body once a month and if you see an abnormality contact a doctor for a full exam.

USPS expands Wounded Warriors Leave

USPS recently updated the Wound Warriors Leave policy effective January 5, 2019. Eligible military veterans will be credited with 104 hours of Wounded Warriors Leave **each leave year** going forward. This is a significant improvement over the previous policy which provided this benefit as a one-time occurrence only.

The Postal Service released an updated Management Instruction EL-510-2019-2 (M-01901) setting forth policy guidelines and standard procedures for administering this category of leave. This new instruction replaces Management Instruction EL-510-2016-8 (M-01881).
