

MEMORANDUM - May 21, 2020

To All Region 12 Branch Presidents

RE: TAKE ACTION

I want to thank those of you who took the time to listen to the May 14, 2020 Pennsylvania Web-Meeting hosted by NALC LPO, Marc Ashmon, Special Assistant to the President, Eddie Davidson and me.

Hopefully the web-meeting helped to reinforce how important it is that every letter carrier Take Action every time the NALC notifies our members to do so.

Sadly, the Web-Meeting verified that some of our members are skeptical about the value of the Take Action program. They do not realize that they should <u>send frequent messages to our representatives on Capitol Hill</u>. Those messages should ask <u>ONLY</u> that their representative support/approve the bill for the help we need to sustain the Postal Service during our current crisis.

During the web-meeting some members messages to the entire group that worked against our goals. Those messages showed that some carriers truly believe that the Postal Service will not go away. These Letter Carriers think that if USPS mail delivery stops, that stop will be temporary. They believe they will return to work because "a USPS stop in service" will create an unmanageable amount of mail to be delivered around our country.

This type of thinking does not recognize that since taking office the current administrations goal is to dismantle the United States Postal Service and replace it with a low wage – no health benefits workforce that has no representation rights.

Having a "I heard it all before attitude" is extremely dangerous. Private delivery companies are growing rapidly. Those small startup companies are trying to diminish the importance of the Postal Service. In addition to these small companies' large delivery businesses like UPS and FedEx have their own well-funded networks they use to contact Capitol Hill to lobby in favor of privatization.

Enclosed with this letter is a copy of Pennsylvania State Association of Letter Carriers Bulletin published by our State President Paul Rozzi. All of you already received a copy of the Bulletin but I believe you need to read it again. Paul's message simplifies our situation and outlines our need to frequently reach out to our representatives and ask that they support the funding we need to survive.

I ask that you send this Memo and the PA State Bulletin to your Stewards. Ask them to read it and POST it on the NALC Bulletin Boards in every office your Branch represents.

# Ripple Effects of Covid-19 ACTION NEEDED

Regardless of your thoughts on the corona virus situation, whether you believe it to be a hoax or a terrible plague, whether you believe the response to be way overblown or think that it has fallen woefully short, the effect on the economy has been devastating and has resulted in at least a 50% drop in Postal revenues with no end in sight. Our government is attempting to stimulate the economy by sending checks to individuals and providing funds to corporations and entire industries. The Postal Service and letter carriers however, have been completely left out of those stimulus packages and it seems to be tactical. The situation is as follows:

USPS is currently at its debt limit.

Simply increasing the debt limit without direct funding will not solve anything. The Postal Service did absolutely nothing to cause or contribute to the current situation.

At some point this summer USPS will not be able to cover expenses or make payroll.

All of you should be well aware of the last few WH budgets, the WH postal task force report and the massive cuts proposed.

Without direct stimulus funding to the Postal Service, how do you think they will accomplish Postal solvency?

I learned today that the administration proposed \$97B in wage and service cuts. Everything would be on the table !!! Everything !!! WAGES, current and future PENSIONS, COLAS, LAYOFFS, HEALTH PLAN and COLLECTIVE BARGAINING itself.

Congress has complete and total oversight of the USPS and while many members of congress support us we have to make damn well sure that they stay with us on these issues. A small group of letter carrier activists have worked long and hard to build that support.

But, in the midst of this disastrous situation those same few activists are carrying the load again. The number of congressional contacts made so far on the NALC app is PATHETIC and will not get the job done.

We have to focus solely on this one issue and see it through.

Each of us on this telecom has to make use of the APP multiple times and commit do all we can to get everyone else to do the same and keep it going.

Use of the APP is quick and extremely user friendly. This is an issue we can win. Our jobs and our future depend on it.

We are at the end game stage. It's time for all letter carriers to speak up, stand up and get this done.



- Each year, more than 4.5 million people in the U.S. are bitten by dogs.

- Senior citizens are the second most common dog bite victims.






